It is recognised that the judgements about what sacrifices a family should make to pay school fees will be personal and the level of awards is therefore not rigid. The award of a bursary is specifically to allow a child whose parents may not otherwise be able to afford tuition fees to benefit from a place at our school. The award is not intended to support a pre-existing lifestyle. The Governors therefore consider that the following would not be consistent with the award of a bursary:

1. Household income (gross income) in excess of £65,000
2. Net assets should not exceed £300,000
3. Substantial savings or investments of more than £60,000
4. Receipt of any means-tested State Benefit
5. If only one parent is employed (unless one is prevented from doing so through incapacity)
6. More than one property
7. Investment in significant home improvements
8. Mortgages on excessively expensive properties
9. Substantial equity in homes
10. Frequent or expensive holidays
11. New or luxury cars

It is expected that applicants who wish to be considered for an Art Scholarship will show considerable natural ability and will have begun to reach high standards of proficiency in their creative work in terms of technique, development of ideas and their understanding of the subject. We will be looking for enthusiastic individuals who make the subject a major part of not only their school life but also their free time, and are able to respond to the creative possibilities of the subject.

Applicants are asked to submit a portfolio of recent work and should bring this to the school on the day of the Entrance Exam. After the work has been inspected, a shortlist of applicants will be invited to take part in an observed drawing exercise and a short interview with their portfolio of work. Inclusion on the shortlist will be dependent upon the necessary academic standards being met.
